



APPLICATION, EXEMPTION OF LIABILITY & CONSENT FORM

Terms and Conditions

By indicating your acceptance, you understand, agree, warrant and covenant as follows:

I hereby for myself my heirs, executors and administration, waive any and all rights and claims for damages I may have against INTI International College Subang, all sponsors, coordinating groups and any individuals associated with this event, their representatives, successors, assigns, and will hold harmless for any and all injuries suffered in connection with this event. I attest that I am physically fit to compete in this event. Further I grant full permission to an and all foregoing to use my likeness in all media's including photographs, pictures, recordings, or any other record of this event for any legitimate purpose.

REGISTRATION AGREEMENT AND LIABILITY WAIVER (the "Agreement and Waiver")

1. Authority to Register and/or to Act as Agent. You represent and warrant to INTI International College Subang ("IICS") that you have full legal authority to complete this event registration on behalf of yourself and/or any party you are registering (the "Registered Parties"). As used in this Agreement and Waiver, IICS refers to INTI International College Subang and any and all subsidiaries, affiliated entities, or entities that control or are controlled by IICS singly or together and its officers, employees, contractors, subcontractors and agents. If you are registering a child under the age of 18 or an incapacitated adult you represent and warrant that you are the parent or legal guardian of that party and have the legal authority to enter into this agreement on their behalf and by proceeding with this event registration, you agree that the terms of this Agreement and Waiver shall apply equally to all Registered Parties. By registering a child under 13, you agree and consent to the collection of that child's information which you provide for the purposes of registration.

2. Waiver.

You understand that participation in the event is potentially hazardous, and that a registered party should not participate unless they are medically able and properly rained. You understand that events may be held over public roads and facilities open to the public during the event and upon which hazards are to be expected. Participation carries with it certain inherent risks that cannot be eliminated completely ranging from minor injuries to catastrophic injuries including death. You understand and agree that in consideration of being permitted to participate in the event, you and any registered party, the heirs, personal representatives or assigns of you or the registered party do hereby release, waive, discharge and covenant not to sue IICS for any and all liability from any and all claims arising from participation in the event by you or any registered party.

3. Limitation of Liability; Disclaimer of Warranties.

IICS shall not be liable for any direct, indirect, incidental, special or consequential damages, resulting from (a) the use or the inability to use IICS or (b) for the cost of procurement of substitute goods and services or (c) resulting from any goods or services purchased or obtained or transactions entered into through IICS or (d) resulting from unauthorized access to or alteration of your transmissions or data, including but not limited to, damages for loss of profits, use, data or other intangible, even if IICS has been advised of the possibility of such damages. You expressly agree that use of IICS is at your sole risk. IICS is provided on an "as is" and "as available" basis. IICS expressly disclaims all warranties of any kind, express or implied, including without limitation any warranty of merchantability, fitness for a particular purpose or non-infringement.

IICS makes no warranty that the IICS sites' services will be uninterrupted, secure or error free. IICS does not guarantee the accuracy or completeness of any information in, or provided in connection with, the IICS sites. IICS is not responsible for any errors or omissions, or for the results obtained from the use of such information. You understand and agree that any material and/or data downloaded or otherwise obtained through the use of the IICS sites is at your own discretion and risk and that you will be solely responsible for any damage to your own computer system or loss of data that results from the download of such material and/or data.

4. Indemnification.

5. Severability.
